This Deed made this 31st day of January in the year Nineteen Hundred and Eleven by Samuel T. Brandenburg and Susan E. Brandenburg, his wife, and John W. Bussard, Peter E. Bussard, Samuel D. Bussard, Daniel L. Bussard, and Joseph H. Bussard, Trustees, Assignees, of Peter H. Bussard, Mortgagee, Witnesseth: That in consideration of One Hundred and Fifty Three Dollars and Seventy-five Cents (\$153.75) the said Samuel T. Brandenburg and Susan E. Brandenburg does hereby grant and convey unto Amanda A. Brandenburg, all the following described parcel of land, situate, lying and being in Frederick County, State of Maryland, being part of the land conveyed unto the said Samuel T. Brandenburg by deed executed by Julia Ann Brandenburg, et al, heirs at law of Samuel Brandenburg, bearing date of February 22nd, 1898, and recorded in Liber D.H.H. No. 1. folio 352, one of the Land Records of Frederick County, and beginning for the part hereby intended to be conveyed, at a stone at the end of the 14th line of said deed, and running thence S. 78½° E. 19.84 perches to intersect the 12th line of said deed, and thence with said line S. 26° W. 39.6 perches to the end thereof, N. 77° W. 2 perches, thence N. 1° W. 37.75 perches to the place of beginning, containing 2 Acres, 2 Roods and 10 Sq. perches of land, more or less, And the said John W.
