

CERTIFIED COPY OF LAST WILL AND TESTAMENT OF C. HARRY EYLER, DECEASED.

I, C. Harry Eyer, of Thurmont, Frederick County, State of Maryland, being of sound, disposing mind, memory and understanding do hereby make, publish, declare and ordain this to be my last Will and Testament, in manner and form following:

After the payment of all my just debts and funeral expenses, I give, devise and bequeath as follows:

FIRST: I give and bequeath unto my wife, O. Ruth Eyer, the sum of \$1000.00 to be hers absolutely.

SECOND: I direct that my Executors hereinafter named shall just as soon as it is practical, sell all live stock and convert the same into cash and deposit the proceeds, together with all money in bank or banks in the Detour Bank, Detour, Maryland, on an interest account and the interest or income therefrom to be paid to my widow during the term of her natural life.

THIRD: I give and bequeath all the rest and residue of my personal property unto my wife, O. Ruth Eyer, to be hers absolutely.

FOURTH: I give, devise and bequeath unto my wife O. Ruth Eyer, all of my real estate, wheresoever situated, in trust and confidence nevertheless, she to enjoy the income and profits arising therefrom for and during the term of her natural life, Upon the death of my wife, the within trust shall immediately cease and terminate, and my Executors hereinafter named are hereby authorized, empowered and directed to sell and convey any and all property of which I may die seized and possessed, whether the same be real personal or mixed in order that the same may be converted into money, and I give and nequeath the proceeds thereof to my children, or their heirs, to be divided equally share and share alike.

LASTLY, I hereby nominate, constitute and appoint my sons, Joseph H. Eyer and Charles Wm. Eyer, to be Executors of this my last Will and Testament. I hereby ratify and confirm this and none other as and for my last Will and Testament, revoking any and all other Wills by me made.

IN TESTIMONY WHEREOF, I have hereunto set my hand and seal this 25th day of June, in the year nineteen hundred and thirty-five.
