This Assignment and Deed of Trust made this 3rd day of April, 1945 by and between ST. MARY'S INDUSTRIAL SCHOOL FOR BOYS OF THE CITY OF BALTIMORE, THE ASSOCIATED PROFESSORS OF ST.
