

I give my cherry wood chest of drawers and old mirror to Joseph Richard Staley, the son of my brother, Irving E. Staley, to be delivered to him after the death of my wife, Mollie M. Staley.

I give unto Mount Olivet Cemetery, a body corporate, located at Frederick, Maryland, the sum of One hundred Dollars, (\$100.00) in trust nevertheless, for the purpose of keeping in perpetual care and condition the lot in my name, and the grave stones thereon, in said cemetery.

I give, devise and bequeath all of the rest and residue of my said property and estate, unto my beloved wife, Mollie M. Staley, to have and to hold the same, and to use and enjoy the income and profits arising thereout and therefrom, for and during the time of her natural life, and no longer, and after the death of my said wife, I direct my Executor hereinafter named to sell all of my property and estate, real, personal, and mixed, at public or private sale, as in his discretion will be more advantageous for my estate, and to collect all sums of money due unto my estate, and I give the net proceeds arising therefrom as follows:-

I give unto the Evangelical Reformed Church, of Frederick, Maryland, a body corporate, the sum of \$2,000.00. for the purpose of placing one or two memorial windows in the North end of the Church, the same to be named in memory of Charles A. Staley and Mollie M. Staley, his wife, and same to be of a cost and design that will be appropriate in the judgment of my Executor hereinafter named, together with the Consistory, which is the governing body of said Church, for the carrying out of the purpose for which said bequest is hereby given.

I give unto the Evangelical Reformed Church, of Frederick, Maryland, a body corporate, the sum of \$2,000.00, for the purpose of erecting a new Sunday School building, or for enlarging the present Sunday School building, on the South side of West Church Street, in Frederick City, Maryland, as in the discretion of the Consistory, the governing body of said Church, will be more useful and advantageous for the carrying out of the purpose for which said bequest is hereby given.

I give unto the George W. and Agnes Hoffman Orphanage, and its Successors, located at R.F.D. No. 1, Littlestown, Pennsylvania, the sum of \$500.00.

I direct that my Executor hereinafter named shall divide all the rest and residue of my said property and estate as follows:-

Out of which I give one-fourth equal part to Frances C. Smith, the daughter of Grayson H. Staley, save and subtracting therefrom any and all sums of money that will be due to me personally on any promissory note or notes by the said Grayson H. Staley at the time of my death, and also save and subtracting therefrom any and all sums of money that I, or my Estate will have to pay as a surety or guarantor on any note or notes of the Staley Motor Company, a body corporate of Frederick, Maryland.

I then give all the rest and residue of my said property and estate, then remaining, unto Staley Vincent Sanner, son of Vernon Sanner, deceased; Charles Irving Staley and Joseph Richard Staley, sons of Irving E. Staley, to be divided among them equally, share and share alike.

I hereby direct and require that my Executor hereinafter named be charged with the duty of seeing that my farm lands and dwelling property be kept in good condition and repair, and that all taxes and insurance due thereon during the lifetime of my wife, as life tenant, shall be regularly paid.

I hereby nominate, constitute and appoint my brother, Irving E. Staley, to be the Executor of this my last Will and Testament, hereby revoking all other Wills by me heretofore made, and hereby ratifying and confirming this to be my last Will and Testament and none other.

In testimony whereof, I hereunto subscribe my name and affix my seal unto this my last Will and Testament on this seventeenth day of July, in the year nineteen hundred and forty.
