

(a) I give and bequeath One thousand dollars (\$1000.00) to my wife, Mary Ada Culler, absolutely.

(b) I direct that a sufficient amount shall be retained to comply with the provisions of Item 5 herein.

(c) The rest or residue of said proceeds I give and bequeath to my child or children, absolutely, share and share alike; and in event a child is a minor then my Executrix shall deposit the share of said child in bank, the interest therefrom to be used towards the support, maintainance and education of said child, said child to receive the principal in his or her full control on coming to legal age.

Item 7. Should my said wife, Mary Ada Culler, re-marry and there be no child or children of a deceased child, of mine then living, then and in that event my estate and property shall be converted into cash by sale, in the same manner as directed in Item 6, and the proceeds therefrom I dispose of as follows, to be paid as soon as possible.

(a) I give and bequeath to my wife, Mary Ada Culler, the sum of One thousand dollars (\$1000.00) absolutely.

(b) I give and bequeath to my wife, Mary Ada Culler, the interest and income from the sum of Five Thousand dollars (\$5000.00) for and during her natural life, and from and after her death I give and bequeath said sum of Five Thousand dollars to my brothers and sisters, share and share alike.

(c) The rest and residue of said proceeds I give and bequeath unto my brothers and sisters and the brothers and sisters of my wife, Mary Ada Culler, share and share alike.

Item 8. Should my said wife, Mary Ada Culler, live and die my widow, then from and after her death I give, bequeath and devise unto my child, or children as the case may be, all of my estate and property, real, personal and mixed, except that disposed of in Item 2 and 5 herein, absolutely, share and share alike, the child or children of a deceased child to take its or their parent's share.

Item 9. Should my said wife, Mary Ada Culler, live and die my widow and there be no child, or children of a deceased child, of mine surviving her, then I will and direct that, on her said decease, all of my estate and property, real personal and mixed, then remaining, except that disposed of in Item 2 and 5 herein, shall be sold and converted into cash, to go as as follows:

(a) I give and bequeath Five Hundred Dollars (\$500.00) to the Trustees of the Frederick Presbyterian Church, absolutely.

(b) I give and bequeath Five Hundred Dollars (\$500.00) to the Frederick City Hospital Association of Frederick County, Maryland, absolutely.

(c) I give and bequeath Five Hundred Dollars (\$500.00) to Hood College, Frederick, Maryland, absolutely.

(d) I give and bequeath One Hundred Dollars (\$100.00) to the Frederick County Free Library Association, said sum to be expended in the purchase of new books for the Library of said association.

(e) I give and bequeath Two Hundred and Fifty dollars (\$250.00) to the Trustees of the Frederick Presbyterian Church and request that said sum be used for the benefit of the Sunday School of said Frederick Presbyterian Church, this request however not be impose any legal or equitable obligation on the said Trustees of the Frederick Presbyterian Church.

(f) All the rest and residue of said Cash I give and bequeath unto my brothers and sisters and the brothers and sisters of my said wife, said rest and residue to be divided among them in such proportion that the share of each of my brothers and sisters shall be twice as large as the share of each of the brothers and sisters of my said wife, Mary Ada Culler.
