

ORDER OF PUBLICATION
 IN THE CIRCUIT COURT FOR FREDERICK COUNTY, MARYLAND
 IN EQUITY.

No. 17318 Equity.

Charity B. Street, vs. James H. Falk, Collector of taxes for Frederick County, Md., Adolph Gold, reputed owner of property, 4-acre tract, Urbana District, Frederick County, Maryland, assessed in the name of Adolph Gold, Eugene Traver, Acting Collector of Internal Revenue, and all persons having or claiming to have any interest in said property.

The object of these proceedings is to secure the foreclosure of all rights of redemption in the following property, to wit: - 3 A. 's., 3 Rs., and 34 sq. pcs. of land, in Urbana District, Frederick Co., Md., deed from Morris Cromwell, unmarried, to Adolph Gold, dated 3/31/47, Liber 462, folio 79, one of the Land Records of Frederick County, Md.

The Bill states, among other things, that the amount necessary for redemption have not been paid, although more than a year and a day from the date of sale has expired.

The Bill further states that the said Adolph Gold, reputed owner, is a non-resident of the State of Maryland and at present his whereabouts are unknown, and that there is a tax lien on record in the Circuit Court for Frederick Co., Md., placed there at the instructions of the Collector of Internal Revenue for the U. S.

It is thereupon, this 26th day of April, 1952, by the Circuit Court for Frederick County, Maryland, in Equity, ORDERED that notice be given by the insertion of a copy of this order in some newspaper having a general circulation in Frederick County, Maryland, once a week for four successive weeks, warning all persons interested or claiming to have an interest in the said property to be and appear in this Court by the 28th day of June, 1952, and redeem the property mentioned herein and answer the Bill of Complaint, or thereafter a final decree will be rendered foreclosing all rights of redemption in the property, and vesting fee simple title in the Complainant, free and clear of all encumbrances.
