POURTH: That by virtue of the language of the two Wills aforesaid, being "Exhibit No. 1" and "Exhibit No. 2", the ownership of the aforesaid real estate referred to in "Exhibit No. 3" descended unto the following children of Maggie S. Lee and Daniel Webster Lee, Sr. as tenants in common, namely, Rachel L. Webster, who has inter-married with Lewis Webster and resides in Baltimore, Maryland, Elsie Swain, who has inter-married with Oath Swain and lives in Bethesda, Maryland, William F. Lee, who has inter-married with Charlotte Lee and resides at Adamstown, Maryland, Carrie Wine who has inter-married with George Wine and resides at Lovettsville, Virginia, Louise Rasterday, who has inter-married with Frank Easterday and resides at Mt. Airy, Maryland, Myrtie Henley who has inter-married with Albert Henley, who resides at Rockville, Maryland, Ethel Poole who has inter-married with Monroe Poole, who resides in Frederick, Maryland, Daniel W. Lee, Jr., who has inter-married with Evelyn S. Lee, who resides in Adamstown, Maryland, and Robert E. Lee, who has inter-married with Betty Lee, who resides in Frederick, Maryland, the aforesaid being all and the only children of the aforesaid Maggie S. Lee and Daniel Webster Lee, Sr.

FIFTH: Your Complainants represent to your Honorable Court that the land hereinabove described is not divisible without loss or injury to the parties entitled, and
that it would be to the best interest of all the parties to this cause that said land be
sold and, after the payment of the usual Court costs and expenses, the proceeds therefrom
to be distributed to the parties hereto, in accordance with the respective interests in
said real estate, as determined by the laws of descent of the State of Maryland.
