It is further agreed by and between the parties hereto that the Parties of the First Part shall provide, at their expense, the deed of conveyance, and shall further furnish Federal Revenue Stamps requisite for said deed, but that the Parties of the Second Part shall furnish, at their expense, the Maryland Stamps required for said deed, and shall bear all other costs incident to the proposed transfer.
