 spectfully shows unto your Honors:

1. That on the 10th day of April, 1961, Charlotte W. Yarroll, County Trea-  
 surer and Collector of Taxes for Frederick County and the State of Maryland,  
 sold unto Harry K. Green and Ethel V. Green, his wife, at public auction for the  
 sum of Two Hundred Fifteen Dollars (\$215.00), a lot of one (1) acre of land,
