ORDERED: That notice be given by

warning all persons interested in said
property to be and appear in this Court
by the 15th day of October, 1962, and
redeem the property all that lot or par-
cel of land, one (1) acre, more or less,
with the improvements thereon, on Wel-
ler Road, lying and being in New Mar-
ket District, No. 9, Frederick County,
Maryland, and answer the bill or there-
after a final decree will be rendered
foreclosing all rights of redemption in
the property, and vesting in the Plain-
tiffs a title, free and clear of all en-
cumbrances.
