STRIKERS REINFORCED.

U. S. Troops Powerless at Keyser.

Call for Another Detachment.

GRAFTON IN POSSESSION OF THE MOB.

THE PIEDMONT MINERS.

STOPPING A TRAIN AT SIR JOHN'S BURN.

MARTINSBURG, W. VA., July 20.—One of trains which left for the West this A. M., was out off at Sir John's Run. After short delay it was coupled up and went on.

Captain Litchfield has gone on with two companies of troops to prevent a repetition of the act and will endeavor to arrest those engaged in it. No further interference at that point is apprehended.

THIS MORNING AT OMBELAND. OMBELAND, July 20.—The rioters here are on the increase, and the most intense excitement prevails in the town. It was nearly two o'clock this morning before the strikers would allow the West bound train, which left Martinsburg yesterday afternoon at 8:45, to pass. In vain the companies' authorities and the detachment of soldiers on the cars attempted to disperse the crowd, but they only surged back to charge in greater numbers with such succeeding effect. At length, however, the soldiers were obliged to make a bayonet charge upon the mob, and the strikers falling back, the train shot off amid the curses and threats of the defeated insurgents.

ALARMING SITUATION AT KEYSER. KEYSER, W. VA., July 20.—This morning the strikers at this place are out in large force, and very defiant in their actions. They have been reinforced by several hundred men and swear vengeance against any man who dares to attempt to take out a train.

NO MORE MEN HERE. The squad of United States soldiers who arrived here in charge of a train found it impossible to cope with the immense army of insurgents who had been sent to Martinsburg and with the mob of seventy five men. Additional soldiers at this place are not in large force, and very defiant in their actions.

THE MOB AT THREE MERCY and the last movement on the part of the latter would have resulted in a general slaughter. The arrival of the seventy five extra men has so far had no intimidating effect upon the rioters and a similar demonstration would not be surprising at any moment.

MINERS JOIN THE STRIKERS. PIEDMONT, W. VA., July 20.—The excitement at this place is greater than has been for years. All and peacefully disposed citizens, in vicinity are terribly alarmed. Between three and four hundred miners are ready to join the strikers of the West; they are called upon. These men require a desperate set of men, and will give great trouble to the authorities.

The first west bound train yesterday was met at Cumberland at midnight by several hundred ruffians, supposed to be exiles.

A LOCOMOTIVE WOKERED. They opened the switch and the locomotive was thrown from the track.

When this information reached Col. French he instructed the troops at Cumberland to protect trains at all points.

There are plenty of men here this morning ready to engage with to take the place of the strikers but the company will not let them.

GRAFTON IN POSSESSION OF THE INSURGENTS. GRAFTON, W. VA., July 20.—The situation here grows hourly more alarming. Judging from the

present state of affairs the United States troops will have their hands full in suppressing the insurrection. Everything in the hands of the strikers, and no trains are allowed to pass either way. The first attempt to move anything will be the signal for a fierce and determined resistance.

New York Central and Erie. Arrives received in Baltimore to-day from Elmira, New York, report a strike among the Erie Railroad hands at that place. The strikers constitute a large body, and are being rapidly reinforced.

CIVIL AUTHORITIES DEFEATED.

GOVERNOR OF PENNSYLVANIA CALLED ON FOR TROOPS. PITTSBURGH, Pa., July 20.—It has just been learned from a reliable source that Sheriff Fife, of this county, has telegraphed Governor Hartranft, in possession of the Pennsylvania Railroad tracks, and asked him to give his authority in the premises by calling out the military for that purpose.

THE TROUBLES AT PITTSBURGH—CIVIL AUTHORITIES, &c. PITTSBURGH, Pa., July 20.—At 12 o'clock last night Sheriff Fife, in company with a request from the railroad officials, visited the strikers at Twenty-eighth street, and ordered them to disperse. This they refused to do.

The Sheriff remained there until after 3 o'clock this morning, but his authority was defied. He was informed that trains should not be allowed to pass, and that the Sheriff should care for any force he could muster, but for any troops that could be brought out. Finding that the strikers were not disposed to yield obedience to the civil authority, the railroad officers decided to call upon the military.

THE SHERIFF ASKS FOR TROOPS. The following despatches were at once forwarded to Lieutenant-Governor Latta and Secretary Quay:

The following is the despatch above alluded to: PITTSBURGH, July 19. To Hon. John F. Hartranft, Governor of Pa., Harrisburg, Pa.

A tumult, riot and mob exist on the Pennsylvania railroad at East Liberty, and in the Twelfth ward of Pittsburgh.

Large assemblages of people are upon the railroad, and the movement of the freight trains either East or West, is prevented by intimidation and violence, molesting and obstructing the engineers and other employees of the railroad company in discharge of their duties.

As the Sheriff of the county, I have endeavored to suppress the riot, and have not adequate means at command to do so and therefore request you to exercise your authority in calling out the military to suppress the same.

R. H. FIFE, LANGASTER, Pa., July 20, 3:17 a. m. To H. H. Hays of Allegheny Co., Pa. Have ordered Gen. Pearson to send a regiment of infantry to aid in suppressing disorder.

THE MOUNTAIN REGIMENT. The regiment referred to in Gen. A. L. Pearson's order is the celebrated Duquesne Grays, of Pittsburgh. It is highly disciplined, and is looked upon as the "crack" militia regiment of that city.

BALTIMORE, July 20, 10:45 p. m. Camden Station is flamed—strikers have Fifth Regiment locked in Camden Station—not raging, five or six men seriously injured.

BALTIMORE, July 20.—12:30 A. M.—The Fifth and Sixth Regiments were ordered by Gov. Carroll to proceed to Cumberland this evening.

The Fifth marched from its army camp at Camden Station. The soldiers in the cars were very frequently struck as they passed along. A mob followed July 14th.

them all the way, and they were obliged to charge through the crowd with fixed bayonets to get into the depot. The Sixth Regiment was being engaged in its army by an infuriated mob the house was stoned and many of the soldiers were struck with bricks and stones—they fired on the mob from the windows and killed two or three persons. The regiment did not attempt to form and most of the soldiers remained in their army or ran away. One company started for Camden depot and as it marched up Baltimore street had a regular fusillade with the mob; four or five persons were killed between the bridge and Light street. The mob here held possession of Camden station all night and neither the soldiers nor the police have been able to drive the rioters away. They repeatedly set fire to the depot and the round house is now burning.—The rioters still unobeyed us at 12 midnight.

BALTIMORE, 1:30 a. m.—The strikers still in possession of the streets, depot and road. They are tearing up the rails.

Union Pacific. PROPOSITION TO END REDUCTION OF RAILROAD WAGES. CHICAGO, Neb., July 20.—About 200 employees of the Atlantic and Pacific Railroad held a meeting here last night for the purpose of discussing the recent reduction of from 5 to 10 per cent in their wages. A committee was appointed to confer with Representative Clark, and the meeting adjourned to meet Monday night.

STRIKERS FLEED IN MICHIGAN. DOWROTT, Mich., July 20.—Apprehensions of trouble from railroad engagements and drawn on account of the reduction in their wages exist here.

THE WAR.

Heading off the Turks. LONDON, July 19.—A despatch from Bucharest states that 50,000 Russians are advancing from Nicopolis on Widin to prevent a junction of the Turkish and Bulgarian armies.

The Bulgarians have resumed the bombardment of Widin.

PASHA-SWOPPING BY WHOLESALE. LONDON, July 19.—A despatch from Constantinople says that Mehmet Ali will succeed to the command as Generalissimo of the Turkish army in Bulgaria, and that Suleiman Pasha will take command in Roumania, and Assim Pasha will replace Mehmet Ali at Adrianople.

UNWARRANTABLE IN CONVICTION. CONSTANTINOPLE, July 19.—A reign of terror exists in Constantinople. The country lying between the city and Adrianople is really defenceless, and the Christian population are terrified and fear a massacre by the Turkish irregulars.

AMPUTATION OF AN ARM.—On Monday morning last, Dr. Wm M. Witherspoon, assisted by Drs. C. A. Howland and Geo. A. Hondricks, amputated the right arm of Miss Emma Dingham, aged about 17 years, and daughter of Mr. John Dingham, who resides on West Main street in this borough. The disease which necessitated the amputation has an interesting history. More than one year ago a tumor formed on the arm in the region of the elbow, which was supposed to be the result of an injury received by carrying a heavy laden pail. After it had assumed some magnitude it was removed by Dr. Witherspoon. The wound healed kindly, and it was thought by all that relief was complete, but in a short time it returned and assumed a malignant form, when amputation was advised, but the family objected, hoping it would be cured by means of medicine. The tumor continued to grow rapidly, and finally to suppurate, which was away the cause of a large artery. On Sabbath last the tumor broke from the pressure of the blood, and violent hemorrhage occurred, which would have been fatal had the patient not possessed great courage and presence of mind and grasped the artery until assistance arrived. Amputation was now the only thing that could be done to save her life, and the operation was very skillfully performed by Dr. Witherspoon. The patient was much exhausted from loss of blood but bore the operation well, and at this writing (Tuesday noon) is gaining strength and resting quite easy. Shippingport Chronicle.

CANAL AFFAIRS.—It was the current opinion yesterday that the Baltimore & Ohio strike would help the counterpart undertaking of the inland navigators at Sir John's Run, and would probably lead to some compromise between boatmen and shippers. This theory seems to be borne out by the undisputed fact that yesterday one of our most extensive boat owners and large priv. to shippers interfered a number of agents with reference to having all the companies submit a proposition to the boatmen offering \$25 and 90 cents to Georgetown and Alexandria respectively; so to unite on a request to the canal company to reduce tolls 5 or 10 cents, the said reduction to be given to the boatmen, thus making the rates to Georgetown and Alexandria respectively, 90 and 95 cents, or 99 cents each \$1.00, according as the canal company may concede a reduction of 5 or 10 cents. The suggestions of the gentlemen were generally well received by the agents, and by to-morrow we may be able to chronicle a movement of this kind taking practical steps. It is thought that some reduction may be made by the canal company if not clearly guaranteed that the boatmen will get the benefit of it.
