And further we doe hereby grant full power & auth^{ty} vnto him o^r s^d L^t to appoint from time to time fitt places for publike Ports for lading ships vnlading & discharging of all goods & merchandises to be imported or exported into or out of o^r s^d p^vince & to appoint officers & ministers in the same places & ports, & also to erect & establish convenient places for the holding & keeping of faires & markets, & to establish faires & markets to be there held vpon certaine daies for that purpose to be by him appointed. And we doe further by these p^{nts} grant full power & author^{ty} to him o^r S^d L^t (if he see cause) to pardon & remitt in part or in the whole all paines forfeitures or penalties w^{ch} any p^{son} or p^{sons} within o^r s^d p^v: shall incurre for any crime misdemeanor or offence agst any the lawes ordinances or orders whatsoever made or to be made for the good govern^t of the s^d p^v: & to grant pardons for all & every such delinquents in o^r name vnder o^r great Seale of o^r s^d Prov: so as such p^{son} or p^{sons} extend not to the pardoning of highe treason. And further we doe by these p^{nts} committ the custody & keeping of o^r great Seale of o^r s^d p^v: vnto him o^r s^d L^t And we doe hereby further grant vnto him o^r s^d L^t power & authority for vs & in o^r name to passe & grant vnder the same o^r great seale, all writts & processes, all Commissions aswell for authorising such p^{son} & p^{sons} to be of o^r Councell there as we shall from time to time appoint by warrant or direction vnder o^r hand & seale, as for the exequution of iustice, & for dividing & bounding of lands, all pardons licenses & other publike acts & deeds whatsoever w^{ch} shall at any time passe within o^r s^d p^v:

And we doe further hereby grant full power & auth^{ty} vnto him o^r s^d L^t for vs & in o^r name to passe & grant vnder o^r s^d great seale, to such p^{son} or p^{sons} such proportions & quantities of land within o^r s^d p^v: for such estate & interest, & wth such priviledges & immunities, as we have or from time to time shall give him o^r s^d L^t warrant for vnder o^r hand & seale; all w^{ch} grants so to be made passed or granted after the same grants & the said warrants vnder o^r hand & seale for the passing therof shalbe enrolled by o^r Secretary of the s^d p^v: for the time being; And after that o^r s^d Secretary shall have certified vnder his hand vpon the backside of every such grant, that the said grant & warrant vnder o^r hand & seale for passing therof are inrolled, & that the grantee or grantees have p^{formed} the conditions of plantaons; (if the grant be passed by vertue
