

Lord & Proprietary of the same. To all p^rsons to whom these p^rnts shall come Greeting in Our Lord God Euerlasting Know Yee th^t taking into Consideracōn the Petition of diuers p^rsons well affected to this Prouince now or late Inhabitants of North-ton County, otherwise called Accamack in Virginia, who are desyrus to transplant themselues & families into this Prouince. And for the more speedy & effectuall prosequōn of his s^d L^{ps} Command to mee to see that part of this Prouince next adioyning to the County afores^d poepled. And for the ease & benefitt of all such p^rsons who shall transplant themselues into this Prouince from Accamack afores^d I haue nominated constituted & impowred & doe by these p^rnts nominate constitute & empower John Elzey, Randall Reuell, & Stephen Horsey, or any Two of them, being wthin this Prouince to graunt War^{ts} for Land, (during the tearme of Three months next ensuing the date hereof) uppon the Easterne shoare of this Prouince in any part below Choptanck Riuer. That is to say ffifty Acres for Euery p^rson transplanted uppon such Condicōns & tearmes, as are expressed in his L^{ps} Condicōns of Plantaōn now remayning uppon Record regulated according to his L^{ps} Declaraōn of the 22th of septemb^r 1658. now uppon Record allso. Prouided that Euery p^rson clayming any Land by uertue of the Condicōns afores^d for & in respect of the transportaōn of any p^rson or p^rsons into this Prouince, Doe before the s^d John Elzey, Randall Reuell & Stephen Horsey or any Two of them, & being wthin this Prouince, take the Oath of ffidelity by the s^d Condicōns of Plantaōn requyred. W^{ch} s^d Oath the s^d John Elzey, Randall Reuell, & Stephen Horsey, or any Two of them, are hereby impowred to administer, to all or any the p^rsons desyrus to transplant themselues as afores^d, before they shall haue any Warr^{ts} graunted unto them respectiue-ly. And allso Prouided that all such p^rsons as shall haue any war^{ts} graunted be accomptable to the Secretary for the time being for all such ffees, as for the s^d War^{ts} & Entryes shall become due. And the s^d John Elzey, Randall Reuell & Stephen Horsey, are hereby requyred to keepe a Booke of all such Rights & wor^{ts} as shall bee by them or any of them graunted, distinctly recyting the name & sirname of Euery p^rson for & in respect of whose transportaōn they haue allowed any Land. And the same att the end of the Three months afores^d to Returne into the Secretaries office signed wth their hands. And for as much as in a place now poepled some differences may betweene p^rty & p^rty arise, or crimes be p^rpetrated & committed. ffor the Conseruaōn of the Peace, & better Gouvern^t of the Poep-
le there residing. Wee doe hereby empower the s^d John Elzey, Randall Reuell & Stephen Horsey, or any Two of them to heare and Determine all Causes not exceeding Two Thowsand
