they shall be found within his Bailywick) and them safe keepe,  
soe as to have them before his L<sup>sp</sup>s: Justices of the Provinciaall  
Court to be holden at the City of S<sup>t</sup> Maries on the last Tues-  
day in Novemb: next, to answer unto such matters and thinges  
as shall then and there (in behalf of the R<sup>t</sup> hon<sup>ble</sup> the Lord  
Prop<sup>ry</sup>) be objected against them: And that the s<sup>d</sup> Sheriff also  
summons M<sup>r</sup> Edward English and M<sup>r</sup> Edward Jones, that (all  
excuses sett apart) they also be and appeare at the time and  
place aforesaid, to testifie the truth of their knowledge against  
them the s<sup>d</sup> Swithen Wells and Samuel Wheeler, whereof  
lett there be no faile. Dated at the Councill Chamber at the  
City of S<sup>t</sup> Maries the Seaventh Day of October in the Tenth  
yeare of the Dominion of the R<sup>t</sup> hon<sup>ble</sup> Charles &c<sup>a</sup> Annoq  
Dmi 1685:
