opposicon in the lawfull Execucon of all or any of the Powers  
and Authorities hereby Given and Granted to Sue Implead  
and Imprison all & every person & persons whatsoever that  
shall detain possess dispose purloyn or imbeazle any of such  
Wrecks and premisses before particularly mentioned so  
belonging to Us or either of Us by virtue of the said Grant or
