Sr Thomas Laurence Bond to indemnify his Ex^{ncy} for granting a Permit &ca Know all mem by these p^rsents that wee Sr Thomas Laurence Baron^t and Principall Secretary of Maryland and Robert Mason of Sn^t Maries County Gen^{tl} are holden and firmly bound unto his Ex^{ncy} ffrancis Nicholson Esq^r Cap^t Gen^l & Govern^r in Chief of this their Ma^{ts} Province of Maryland in the full sume of ffive hundred pounds good and Lawfull Money of England to be paid to the said ffrancis Nicholson his heirs or Successors Govern^{rs} of Maryland To the which paym^t well and truly to be made Wee bind ourselves our heirs Ex^{rs} and Adm^{rs} Joyntly and Severally for & in the Whole firmly by these p^rsents Sealed with our Seales and dated this day of November Anno Dom 1694

The Condiçõn of this Obligacon is such that whereas the above mencõned ffrancis Nicholson Esq^r Govern^r of Maryland as afd hath this day granted Unto the aboue bound Sr Thomas Laurence a pmitt to transport himselfe out of this Province with directions to all Ma^{rs} of Ships or other Vessells that they may Safely Transport the said Sr Thomas Laurence as afd In as much as his said Ex^{ncy} ffrancis Nicholson Esq^r had taken sufficient caution & Security for the paym^t of such Debts (if any) as the said Sr Thomas Laurence doth owe in this Province According to the Act of Assembly of this Province If therefore the said Sr Thomas Laurence and Robert Mason or either of them their heirs or Assigns shall in all respects Indemnifye his said Ex^{ncy} ffrancis Nicholson Esq^r for his granting the said pmitt or Lysence To the said Sr Thomas Laurence According to the Tenno^r of the said Act of Assembly that then this Obligacon shall be void or Else to stand in full force and virtue in Law.
