Ordered that the Sherriff of each Respective County wth in this Province make inquiry what persons are Empower'd or Commissionated to Range for wild horses, And that the said Sherriffes learn and inform themselves by the best Means & Wayes they can, what wild horses have been taken up since his Ex^{ncies} Arrivall & how disposed off, and that notice be given to all such Rangers & other persons ranging & taking up wild horses, hogs or Cattle, as well with as without Lycense, that for the future they altogether Surcease & forbear ranging for and taking up any Wild horses, hogs or Cattle, not properly belonging to themselves, vnder paine and perill that shall fall thereon, hereby comāding the said Sherriffes to make due Returne unto this Board by the Second day of October next, how they shall have Executed this Order.

You are pursuant to an Act of Assembly of this Province passed the 9th day of June Anno 1692: intituled an Act to the Act for the Settlem^t of an Annuall Revenue upon their Ma^{ty} Govern^r wth in this Province for the time being, being an Impost of 3^d p hhd upon every hhd of Tobacco exported &^{ca} And by vertue of an Order of Council this day to pay unto me the sume of two hundred twenty seven pounds Eight Shillings & three farthings sterl: for which this shall be your Sufficient Warr^t
