The Acco^{ts} from Maryland have been very short and defective and tho M^r Randolph my Dep^{ty} has as he assures me, often Demanded to have the Receipts & Expence of the Revenue in Maryland more fully Stated, as in other Neighbouring Plantations, yet he Complains th^t no such Compliance has been yet given, which Yo^r Ex^{ncy} will therefore be pleased to Ord^r that I may be Enabled to Satisfye the Lords Com^{rs} of the Treasury and Com^{rs} of the publick acco^{ts} as it is my Duty in Matters of the plantation Revenue.

The Acco^{ts} of the Revenue are to Contain a Charge of the Receipts from the Collecto^{rs} of the Severall Districts of the 1^s p^h And a particular Acco^t of the Receipts of the ffines, fforfietures and Escheats accruing to the King and how they arise. Against which the Discharge is to Contain the particular paym^{ts} out of the Revenue, with the particulars of the Occasion of such paym^{ts}

All which is to be vouched by Duplicates of the Ord^{rs} of the Govern^r in Councill and the Receipts of the paym^{ts} to whom such paym^{ts} are made.
