keep^{rs} Ordered that the Severall Ordinary keepers within the Port of Annapolis give an Acco^t to his Ex^{ncy} (from time to time) of all Strangers Coming to their houses, whether by Land or water; and of all boats, Shallops, and Sloops, and to Signifye from whence they Come and whither they are going; to the End his Ex^{ncy} may have notice, when he has Occasion to Send away dispatches to any parts of the province whereby a great Charge may be Saved to the Countrey in pressing mens horses &c. for the Carrying Such dispatches afores^d.
