It Appearing to this Board from the Certificate of Silas Snow and also from the Confession of George Mann lately an Inhabitant of Kent County in this State that he the said George Mann, was in Company with a Party of Men who took the said Silas Snow in the Government of the three lower Counties in Delaware and carried him to the Enemy who afterwards imprisoned him in the New Jail in Philadelphia. You are therefore hereby empowered and directed to receive into your Custody the Body of the said George Mann, herewith sent, and him safely keep in your Prison to answer for Treason against this State, until he shall be discharged
