

Lib. H. D. Sums as shall at any time be remaining in yo<sup>r</sup> hands to such p<sup>r</sup>son or p<sup>r</sup>sons to whom the same shall be Ordered by the Warrant in Writing or Ord<sup>r</sup> of our Govern<sup>r</sup> or Comānd<sup>r</sup> in Cheif with the advice and Consent of the Council and not otherwise upon any Acco<sup>t</sup> whatsoever.

You shall likewise carefully Transmitt unto the said W<sup>m</sup> Blathwayt every six months or Offtner a ffair State and distinct Acco<sup>t</sup> Examined by his Deputy, with the p<sup>r</sup>ticular vouchers of all such Revenues, duty's Customs, Imposts and Proffits whatsoever accruing to Us and our Governm<sup>t</sup> of Maryland within the s<sup>d</sup> Precinct and of all Money and Vallue of money received and issued by you pursuant to the Ord<sup>r</sup> and Warrant of our s<sup>d</sup> Govern<sup>r</sup> or Commander in Cheif as afores<sup>d</sup> and of all Arrears due unto Us and our Government together with the names and habitacōns of all Such persons as shall remain in Arrears of their paym<sup>ts</sup> as also Duplicates of the s<sup>d</sup> Acco<sup>ts</sup> and papers by the succeeding Oportunity in Ord<sup>r</sup> to be Examin'd by him & p<sup>r</sup>sent<sup>d</sup> to the Comm<sup>rs</sup> of our Treasury for their approbation or disallowance of the particulars therein Contain'd, according to the Course and Practice in the like Case within our Kingdom of England, and in Ord<sup>r</sup> to Receive their directions from time to time for the Improvem<sup>t</sup> of our Revenue.

And to the End you may make and Retain a true and perfect Acco<sup>t</sup> of all Receipts and Payments you are to keep distinct and perfect Entries of the particular branches of our s<sup>d</sup> Revenues in Severall Books to be provided and kept by you for that purpose and to transmit unto the s<sup>d</sup> W<sup>m</sup> Blathwayt a particular Cattalogue or leager of all p<sup>r</sup>sons answerable unto us or Our Governm<sup>t</sup> for any Dutys or paym<sup>ts</sup> whatsoever as also the perticular Sums or vallue of money for which such persons stand Charged and shall be indebted unto us or our Governm<sup>t</sup> of Maryland from time to time together with Copies of all Laws and publick Acts concerning our s<sup>d</sup> Revenues, and you are likewise every six months to transmitt as afores<sup>d</sup> a Cattalogue of Entry's of all Goods or Comōdity's Imported or Exported together with the names of the Ships and an Acco<sup>t</sup> of their Burthen Guns, and men, the Name of the Masters & whither Bound, and Generally you are to keep a Correspondence with our Survey<sup>r</sup> and Audit<sup>r</sup> Gen<sup>l</sup> touching the afores<sup>d</sup> Revenues and to send to him by all Oportunities all such Informations as shall Accrue relating thereto.

And in Reguard that it may happen that there may be Something which cannot be so well foreseen here, as observed by our Govern<sup>r</sup> or Comānd<sup>r</sup> in Cheif, you are therefore to follow such Rules and Directions as you shall from time to time Receive from him for the manageing Collecting &
