Ordered that the Hono<sup>ble</sup> Coll<sup>o</sup> Nicholas Greenberry Judge of his Majesties Court of Vice admiralty on the Western Shore be sworne accordingly at his next appearance in Council; as also the Register and Marshall of the said Court.

Ordered that the Kings Lawyers take care to see the Shipp Expectation (whereof John Tench was Master) strictly prosecuted in his Majesties Court of Vice Admiralty on the Eastern Shore; for breach of one of the Acts of Trade &<sup>ca</sup> and that they give notice thereof to the Hono<sup>ble</sup> Coll<sup>o</sup> George Robotham Judge of that Court, that due proceedings may be made therein accordingly. His Ex<sup>ncy</sup> is pleased to demand of the Board if they know of anything further, for his Majesties service, at present to be Offer'd who say they do not.
