The Condiçōn of this obligation is such, that whereas his
Ex^{ncy} Francis Nicholson afores^d hath commissioned &
appointed the said Iohn West, to be Navall Officer for the
district of Pocomoke wthin the said Province by his Comīssion
bearing equall date with these presents, Now if the said John
West shall well and truly performe the said office according to
the Severall acts of Parliament in that case made & provided
and shall observe the directions contained in the acts of
Assembly of this Province relating to the duty of Navall
Officers and from time to time save defend and keep harmless
the said Francis Nicholson Esq^r from all damage loss and
charges that he the said Francis Nicholson Esq^r shall sustain p. 142
at any time by reason of the said Wests nonperformance of
his said office (so long as he shall enjoy the same) as in the
said severall Laws is Enacted & ordained, then the above
Obligacōn to be voyd & of none effect, otherwise to be &
remaine in full force & virtue
