Know all Men by these presents that We Will<sup>m</sup> Wyvill Edward Dorsey and Charles Carroll of the Port of Annapolis Gentl are hereby holden and firmly bounden unto our Sovereigne Lord King William the third &<sup>ca</sup> in the full and just sum of five hundred Pounds Sterll to be paid to our said Sovereigne Lord King William &<sup>c</sup> his heirs and Successors; to true payment whereof we bind our Selves and every of uss Our heires Executors and adm<sup>rs</sup>, and every of them severally and Ioyntly for the whole and in the whole firmly by these presents Sealed and dated at the Port of Annapolis four and Twentyeth day of December 1697.

The Condition of this Obligacōn is such That Whereas the above bounden Will<sup>m</sup> Wyvill is by the Hono<sup>ble</sup> Edward Randolph Esq<sup>r</sup> Surveyor Gen<sup>rl</sup> of his Maj<sup>ties</sup> Customs on the Continent of America and Islands adjacent appointed and deputed to be Rideing Surveyor not only in the Rivers of Bohemia and Sassafras but also at the heads of all the Rivers on the Eastern Shoare unto Susquehanna River. If he the said Will<sup>m</sup> Wyvill shall well and faithfully execute and discharge the said Office and pursue all such Orders and Instructions as he shall from time to time receive from the Hono<sup>ble</sup> the Co<sup>m</sup>miss<sup>rs</sup> of his Maj<sup>ties</sup> Customs at the Customhouse in London in the Kingdom of England or from the Co<sup>m</sup>miss<sup>rs</sup> of his Maj<sup>ties</sup> Customs and from his Maj<sup>ties</sup> Govern<sup>r</sup> of Maryland for the time being and from the Surveyor Gen<sup>rl</sup> of his Majesties Customs on the Continent of America and Islands adjacent and in all things relating to his said Office honestly & faithfully demeane himselfe. That then this obligation to be voyd otherwise in full force and virtue.
