Prouided allwayes, & upon condition neuerthesse th^t I the s^d Philip Hide doe hereby oblige my selfe, my heyres & Assignes th^t noe Land shall bee taken up, neare the Lands aboue mentioned upon any Rights entred upon my account, upon Record. And I doe hereby oblige my selfe upon demand to acknowledge this p^{nt} writing in order to be Recorded.
