Hall v. Hammond March 28 Walter Hall demands writt of Scire facias agst Anne Hammond the Attorney of John Hammond her husband for 1166^l Tob. & Cask. Writt as followeth to the Sheriffe of S^t Maries County, Ret. the 2^d Day of next Court, 20th Aprill.

Cæcilius &c: To Nicholas Gwyther gentⁿ, Sheriffe of the County of S^t Maries. Because th^t Anne Hammond (Attorney of John Hammond her husband) of Brittons Bay in New Towne hund^d ought to haue payd to Henry ffox of the same place & hund^d afores^d the summe of 1166^l of Tob in Cask uppon the 16th of July 1656, as appeareth to vs uppon view of the Records, w^{ch} are yett unpayd as is alleaged. Wee Command yo^u th^t yo^u make knowne unto the s^d Anne Hammond, th^t shee bee att Our Prouinciall Court on the 20th of Aprill next, wheresoeu^e it be held, to shew if shee haue any thing to say, Why the s^d Tob. should not be leauyed uppon the Lands goods & Chattles of her s^d husband, & to the Executo^{rs} of the s^d Henry be deliuered according to the force & effect of the s^d Judgm^t, And haue yo^u there the names of those persons by whom yo^u haue made this knowne unto her, & this Our writt.

Writt to the Sheriffe of Caluert County to arrest &c: Ret next Pro: Court hold att Calu^et County 20th Aprill 2^d day.

mrk. Cattle ffrancies Armestronge Recordeth his owne proper marke (Viz). The Right eare slitt, the Left eare underkeeld.

Leiu^t Thomas Trueman enters his marke of Cattle, (Viz) The left eare Crop't & slitt. The Right eare swallow tayld'.

Coursey v. Morris John Coursey demands Attatchm^t agst the Estate of Nicholas Morris for 4414^l Tob, It being due for Sheriffs ffees.

Attatchm^t to the Sheriffe of Kent County, according to demand Ret. next Prouinciall Court, holden in Caluert County 20th Aprill next 2^d day.

Husbands v. Pakes Cap^t Richard Husbands demands writt agst Walter Pakes, in an accōn of Debt to the ualew of 500^l Tob.

War^t to the Sheriffe of S^t Maries County to arrest &c: Ret. next Prouinciall Court to be holden in Caluert County, 20th Aprill next, ut suprà Ret. 2^d day.
