Chapter XI An Act for the Benefit of the Poor and Encouragement of Industry.

Whereas several Inhabitants of this Province, especially the poorer by 1744 sort, cannot provide necessary Cloathing, particularly Linen, for Ch. 19 and expired July themselves and their Families, by their produce of their Crops of <sup>1747.</sup> Tobacco in the present low state of that Commodity, and that making Linen Cloth of Flax and Hemp of the Growth of the Country, would be of great Advantage to the People thereof in general, and therefore, and to the end that so useful and beneficial a Work may be Encouraged, It is prayed that it may be Enacted,

in each Encourage-Linen Cloth.
