The Bill, entituled, An Act for the Benefit of the poor, and Encouragement of Industry; was read the second time, and will not pass.

The House met according to adjournment, &c.

M<sup>r</sup> Mackall, M<sup>r</sup> John Goldsborough, Capt. Purnell, and M<sup>r</sup> Robins, have Leave of the House to go Home.

An Ingrossed Bill entituled, An Act empowering the vestrymen and Church wardens of All Saints parish, in Prince George's County, or of the County wherein the said Parish shall be, to purchase Three separate Acres of Land in the said Parish, whereon to Build a Church and Two Chapels of Ease; and to empower the Justices of Prince George's County, or of the County wherein the said parish shall be, to levy on the Taxable Inhabitants of the said parish the sum of Three Hundred pounds, Current Money, for the uses therein mentioned; was read and assented to, and sent to the Upper House, with the paper Bill, by M<sup>r</sup> Wootton, and M<sup>r</sup> Stoddert.

M<sup>r</sup> Hammond, from the Committee of Laws, delivers to M<sup>r</sup> Speaker an Address to the Governor; which was Read, approved and Ordered to be Ingrossed.

A Bill entituled, An Act, for raising Sterling per Hogshead on all Tobacco to be exported, for purchasing Arms and Ammunition, for an immediate supply of arms for the Defence of this province, was read the first time, and ordered to lie on the Table.
