John Hall Caile is appointed Commissary of Purchases for Dorchester County in the room of John Caile Harrison deceased.

Ordered That the western shore Treasurer pay to Thomas Mortimore thirty one Pounds, seventeen shillings and six Pence of the new Emission in lieu of Twelve hundred and Seventy Pounds due him per Account passed by the Dep^y Aud.

That the said Treasurer pay to Capt. Benjamin Price of the 2nd Reg^t nine Pounds, seven shillings and six pence of the same Emission on Account.

An order on the Collector of the Tax for Somerset County in favor of Henry Jackson Esq^r Commissary of the said County for Two thousand Pounds issued the 28th of August last and is this Day returned.
