We wrote to you on the 17th January respecting the Exchange of Capt John Harrison and his Crew Prisoners at New York for Capt Charles Whitehead and his Seamen taken in the Privateer Active and brought in here. M^r Steward who applied to the Assembly for the Release of Captain Harrison is here and anxious to have the former Order carried into Effect. We are at a loss to know what has prevented it and wish you to have recourse to our former on this Subject. We are of opinion that it may expedite this Business if a Parole be granted to Capt. Whitehead and be permitted to go to New York upon an Engagement that he procure the Release of Capt. Harrison in his Stead, and such of Capt. Harrison's Crew against those of Whiteheads and those mentioned in our Letter of the 29th of January.
