I am extreamly sorry chief of the Oznabrigs was sold to M^r James Smith of Frederick before the Receipt of your Exc^y Letter, having inform'd Gen¹ Gist if they were wanted for the State they shou'd have the Preference and so Considerable a Time had Elapsd, from the distance, I had no Idea they had occasion for them neither did the Gen¹ mention any Thing to me on that Subject, when he came to Town.
