That John Anderton of Little Eltonhead man<sup>o</sup>r in Caluert County gent<sup>n</sup> being Tenant uppon sufferance unto th<sup>e</sup> Rich neck, parcell of th<sup>e</sup> s<sup>d</sup> man<sup>o</sup>r, did one Thirty ffoote howse uppon th<sup>e</sup> s<sup>d</sup> man<sup>o</sup>r built for th<sup>e</sup> curing of Tobaccoe, thereon to bee planted, sett on fyre & burne downe to th<sup>e</sup> grownd, And by his Cooper & seruants uppon th<sup>e</sup> s<sup>d</sup> man<sup>o</sup>r did fell timber, & make up into Cask to th<sup>e</sup> number or [p. 140] quantity of 120 Tunne, to th<sup>e</sup> greate damage of yo<sup>r</sup> Pet<sup>r</sup> from whence hee sayth th<sup>t</sup> hee is damnified by th<sup>e</sup> s<sup>d</sup> Anderton to th<sup>e</sup> ualue of Twelue Thows<sup>d</sup> pounnds of Tob, for w<sup>ch</sup> hee brings his suite, & craueth order of this hon<sup>ble</sup> Court. And hee shall pray.

John Norwood p<sup>lf</sup> Declares agst Thomas Hamond dēft in an accōn of th<sup>e</sup> Case uppon Trouer & Conuersion That whereas th<sup>e</sup> s<sup>d</sup> John Norwood (according to order from Capt Thomas Beeson, Cap<sup>t</sup> of th<sup>e</sup> Trayned Band) did seaze & marke Certaine Tob. of John Hammond, W<sup>ch</sup> s<sup>d</sup> Tob soe seized & marked as afores<sup>d</sup> Thomas Hammond ffather to th<sup>e</sup> s<sup>d</sup> John did notw<sup>th</sup>stand dispose of & pay away conuerting th<sup>e</sup> same to his owne use, pleasure & benefitt & th<sup>e</sup> same doth still enioy & possesse much to th<sup>e</sup> p<sup>lf</sup>s dammage. Wherefore th<sup>e</sup> p<sup>lf</sup> of this hon<sup>ble</sup> Court prayeth Judgm<sup>t</sup> to bee possessed of th<sup>e</sup> s<sup>d</sup> Tob. soe uniustly disposed of, in contempt of th<sup>e</sup> Law & gou- ernm<sup>t</sup> here, & likewise for his dammage & Costs of suite.
