

**Liber B B** Warrant to Sherriffe of Talbott County to arrest &<sup>c</sup> returnable next Prouinciall Co<sup>rt</sup> being 9<sup>th</sup> Feb. next

To the hon<sup>ble</sup> the Gouverno<sup>r</sup> & Councill of the Prouince of Maryland—

The humble peticōn of Guy White the Attorney of Will<sup>m</sup> Plumley Sheweth

That Cornelius Comages did upon the 14<sup>th</sup> day of May 1662 assume upon himselfe to pay unto Will<sup>m</sup> Plumley his heires or Assignes the Iust sum of 2218<sup>th</sup> tob: in Caske upon the 14<sup>th</sup> day of Octob<sup>r</sup> 1662 in some place in Petuxent Riuier as by his Specially will appeare which Said Sum of 2218<sup>th</sup> tob: the said Cornelius Comages hath not paid and yet refuseth to pay unto the said Will<sup>m</sup> Plumley to the greate damage of the said Plumley

Wherefore hee prayeth Ord<sup>r</sup> of this hon<sup>ble</sup> Court for speedy paym<sup>t</sup> thereof with Costs and damāges And hee shall pray &<sup>c</sup>.

[p. 136] That Richard Games did upon the 16<sup>th</sup> day of May 1663 Assume upon himselfe to pay Joseph Swett and Bartholemew Cadd their heires or Assignes the Just Sum of 2054<sup>th</sup> tob in Caske which said Tobacco is now past due as by his specially will appeare which said sum of 2054<sup>th</sup> tob: the said Richard Games hath not paid and yet refuseth to pay to the said Joseph Swett and Bartholemew Cadd to the greate damage of them both

Wherefore hee prayeth Ord<sup>r</sup> of this Hon<sup>ble</sup> Court for speedy payment thereof w<sup>th</sup> Cost & damāges—And hee shall pray &<sup>c</sup>—
