 be adjourned & the p.<sup>ties</sup> in the Same pleas Writts Bills processe & pre-  
 cepts & other things whatsoever either in Law or Equity thereupon  
 you p<sup>r</sup>fix the S.<sup>d</sup> 9.<sup>th</sup> day of feeb.<sup>ry</sup> more Over Commanding all the  
 Sheriffs officers and other ministers whatsoever of our Said province  
 of maryland that everyone of them in their Custody detayne all &  
 Singular the writts Bills process and precepts & things whatsoever  
 either in Law or Equity before us at S.<sup>t</sup> Johns on the Said 9.<sup>th</sup> day  
 of february or any other days aforesaid or to be returned & them  
 at the Said 9.<sup>th</sup> day of february at s<sup>t</sup> John's afores.<sup>d</sup> you Cause to  
 be returnd so that on the Same 9.<sup>th</sup> day of february upon the  
 Same writts Bills process & precepts and other things whatsoever  
 to you returned you proceed and make the process thereupon as if  
 those writts Bills process & precepts & other the premisses on the
