A Writt of Erro.<sup>r</sup> issued out y.<sup>e</sup> 7.<sup>th</sup> January 1669 directed to the Com.<sup>rs</sup> of S.<sup>t</sup> maryes Co.<sup>ty</sup> in the plaint between Andrew Woodbury on the behalf of Cap.<sup>t</sup> George Carwen p.<sup>t</sup> Thomas Warner def.<sup>t</sup> after Judgm.<sup>t</sup> obtained in that Court & Execution issued & one Jacob a man Servant of the Said Thomas Warner taken in Execution towards Satisfaction of the debt & damages in the writt of Execuōn Specified

Thomas Warner & Thomas Courtney Giving in Security by Recogn<sup>d</sup> acknowledged before the Hon.<sup>ble</sup> the Chancello.<sup>r</sup> in 4000<sup>ll</sup> Tob: Courtney in 2000<sup>ll</sup> Tob.<sup>o</sup> to make Good the Erro.<sup>r</sup> & pay Cost if the Judgm.<sup>t</sup> be Confirmed
