

Liber CD of Erro.^r the Said James hath put in Sufficient Manucapto.^{ts} for the appearance of him the Said James in our Said Provincially Court before our Said Justices of our Provincially Court on the Said Seventeenth day of October and So from day to day or at any day to him by our Said Court in the premisses p^rfixed or to be prefixed untill the Said writt of Correcting Erro.^r Shall be determined and to Satisfie the Said Richard Smith his Debt and Damages if it Shall happen the Said James the Said Seventeenth day of October or at any other day by our s^d Court p^rfixed Shall not appear or not p^rsecute with Effort that it Shall happen the Said Judgm.^t Should be affirmed Therefore we Command you that from further takeing arresting Imprisoning or him by that Occasion any ways mollesting you altogether Supersede and if him the Said James for that Occasion and no other you have taken him from the prison in w.^{ch} he is So detained if upon that Occasion and no other he is Detained without delay you Cause to be delivered upon peril thereon falling Wittness &c 27.th Aprill 1671

Cæcilius &c To the Sheriff of Calvert County Greeting Whereas you was lately Comānded by a writt of Execution issuing out of our Court of Calvert County bearing date the Second day of march 1669 to take the Body of James Veitch in Execution untill he hath made Satisfaction unto George Alderson of the Sumē of four hundred and Eleven pounds of Tobacco as also nine hundred and Seventy pounds of Tobacco for Costs Expended in the Same Suit according to an Order of the Said Court made the first day of
