The Court haueinge Debated this Matter Longe and findeinge noe cleere prooffe in the Cause to passe Judgm^t upon hath wth th^e concent of the ptyes Refferant the hereinge & Determininge hereof untill the next Court beinge th^e first day of Nou.

M^r Seth Foster Pl^t
Johⁿ Deere Def^t

The Pl^t doth sue for the forfeiture of a bond of two thousand one hundred Pounds of To^b for w^{ch} there was bound ouer a planta^{con} a Cow & a Cropp of To^b the Def^t prouinge all the sd some of To^b payd but nine hundred twenty two lb, w^{ch} th^e Court hath ordered that th^e bond beinge forfeited m^r Foster shall haue the Planta^{con} immediatly in po^{ss}ion, And the Def^t hath Immediatly diliuered to m^r Foster his pattent of th^e sd Land in open Court, but m^r Foster hath giuen th^e Def^t two monethes time to pay th^e To^b, before he turnes him from th^e Planta^{con}

m^r Edd^d Lloyd Plan^t
Johⁿ Deere Deff^t

The Plan^t demands securytie of a Debt of one thousand eight hundred eighty fiue pounds of To^b by two bills w^{ch} th^e Def^t Acknowl- edgeth, & that he hath promised security. The Court doth order & wth th^e Concente of both ptyes That if the Det^r Johⁿ Deere shall not make good paym^t in good Beeffe & Porke to th^e Pl^t m^r Lloyd betwixt and the tenth day of Dec. next at th^e price Curant that then the Plan- ta^{con} belonging to John Deere in Chester Riuer beinge fower hun- dred Acres, to be Lyable to satisfie th^e aboute sd Debt, as alsoe to be bound ouer to th^e Pl^t Immediatly for his security, & th^e Def^t to pay cost of suyt
