These are therefor in th^e Name of th^e Lord Prop^r to will & require yo^w to take into yowr Custody th^e afore sd Sarah Tailer & if by any Lawfull meanes you may use to Conuey her unto her s^d Maisters house, or otherwise to secure her in yo^r Custody For her sd M^r untill th^e next Court to be holden on Kent th^e first day of Dec^r next where by vertue hereof you are required to bringe her to make her Complaint appeare, & th^t you giue timely notice hereof unto her sd Mai^r Thō Bradnox. hereof Faile you not as you will answar th^e Contrary. Giuen this 28th of No^b 1659 And make returne of this writt.
