Know all men p̄ these p^rsents that I Anthony Hillson of London Marriner haue made Ordained Constituted & p̄ these p^rsents doe make ordaine Constitute & appointe my trusty & well beloued Frind William Granger of the County of Kent Planter my true & Lawfull Attorney for me & in my name & for my use to Aske demand & receiue all debts dues & demands & in my name to Arest sue Implead & p̄secute For the same, & upon such sutes to proceed to Judgment & execucon for the same, & thereupon the said Parsons or Parson in Prisson to hold & keep untill sattisfaccon be made wth all Costs & daṃages sustained & to be sustained p̄ occacon of detaineing of all debts & demands, and upon payment & sattisfaccon made to discharge to release & sett out of prisson, and acquittances for me & in my name to make seale & deliuer & allsoe to doe p̄forme & execute all & euery other Lawfull & reasonable Acts both for obtaininge & dischargeing of th^e same and unto my said Attorney I doe giue Full & Absolute power in th^e p^rmisses Rattifieing holdeing Firme all & whatsoeuer my said Attorney shall doe or Cause to be donn in or about th^e premisses p̄ vertue of these p^rsents In Wittnesse whereof I haue hereunto sett my hand & seale this twelth day of Feb^r: in th^e One & twenty yeare of th^e raigne of our Soueraine Lord King Charles th^e second p̄ th^e Grace of God of England Scotland france & Ireland Defendo^r of th^e Faith &c: Anno Doṃ 1669
