


Liber C bargaine & sell Alien Enfeoffee & Confirme, unto him th^e said Morgon Jones his heires & Assignes for Ever All th^t parcell, or tract of land containeing & laid out for one hundred & twenty five Acres be it more or less scituate lyeing & being in kent County in th^e province aforesd Commonly knowne or Called by th^e name of Pentridge, begining at a marked Popler, ruining in length North west fower hundred Pearches & in breadth southwest fittie pearches as by Patten appeares Togeather wth all & singul^r th^e rights & benefittes there unto belonging & also all pattens deedes writeings Evidences Manuscriptes touching or in any wise Concerneing th^e p^rmisses or any part or parcell of th^m with all & singul^r its rightes members Jurisdicōns p^rvilidges proffittes or benefittes belonging or in any wise appertaineing To haue & to hold th^e s^d parcell of land & all & singuler th^e before bargained p^rmisses unto him th^e said Morgon Jones his heires & Assignes for Ever & th^e s^d William Davis both for himselfe his heires Ex^{rs} & Admst^{rs} heareby Covenant & grant to & with th^e s^d Morgon Jones his heires & Ass th^t th^e s^d Wiffim Davis his heires & Ass. th^e s^d parcell or Tract of land & all & other th^e bargained p^rmisses unto him th^e s^d Morgon Joanes his heires & Ass, agst all manner of persons w^{soeuer}, Claimeing by from or under him th^m or any of them shall & will for Ever heareafter warrant & defend by these p^rsentes th^e rentes & services w^{ch} from hence forth from time to time for & in respect of the p^rmisses w^{ch} shall grow dew & payable, to th^e Cheife Lord or Lords, in respect of his or their signory or signoritys onely Excepted & foreprized & further the said Wiffim Davis his heires & Ass. shall & will from time to time & at all times heareafter at th^e request & at th^e prop^r Costes & Charges in th^e Law, of him th^e s^d Morgon Jones his heires or Ass. make doe Execute & suffer, or cause to be made donn Executed or suffered all & Every such further & other Act or Acts thing or things divice or divices assurance or Assurances what socuer requisitt in th^e p^rmisses for th^e better Assureing & sure makeing of th^e said bargained p^rmisses unto him th^e said Morgon Joanes his heires Executors Administrators & Assignes for Ever be it by Inrollment of these p^rsents fine feoffm^t or other wayes or by any other such lawfull wayes or meanes as by him the s^d Morgon Jones his heires or Assignes or his or their Councell learned in th^e Law, shalbe reasonably devised advised or required, In wittnes whereof th^e parties to these p^rsentes have Interchaingably sett their handes & seales th^e day & yeare first aboue written
