William Harris records his mark Cropp & a hole on th^e left eare & a slitt in th^e right eare, with a little Nick under each Eare

William Frisby marke a Cropp & a slitt on th^e right eare, & a square out of th^e under upper side of th^e left eare.

William Trews marke a Cropp & a hole on th^e right eare & a hole & a Nick on th^e upper side of th^e left

Abraham Messeter marke, a Cropp & a slitt on th^e under side of th^e right eare & a swallow fork on th^e left eare.
