& to hould keepe possesse & enioy, peaceably as their own pp goods

Assignes unto th^e afforesd Leeds & Tarrent their heires Execu[~]
Admin[~] & Assignes to keepe indamnified, & saue harmlesse foreuer,
from all letts hindrances & molestations of any p^{son} or p^{sons} what-

it might Concerne may bee kept foreuer Indamnified is willinge to
giue a full discharge, from th^e sd bill & th^e discharge to bee of
generall extent

Bee it known unto all men by these p^rsents th^t I Robert Martin
of the Isle of Kent plant^r haue Remised, Released, & for mee my
heires Exec[~] Admin[~] & Assignes perpetually quite Claymed to
W^m Leeds of th^e same place his heires Exec[~] Admin[~] & Assignes
all manner of Actions as well Reall as p^{sonall}, suites, quarrels,
debts, Executions trespasses and demaundes (mor p^{rticularly} on
thousand pounds of to^b which was due to mee by a Certaine bill
