That whereas John Bun late of this County deceased standeth indebted upon bill dated th^e 3^d day of August 1667 th^e summe of five hundred pounds of tob: to yo^r petition^r as alsoe upon acc^{ot} to th^e vallue of fifty pounds of tob: Now Soe it is that Edward Southrin being willfull administrator to th^e estate of John Bun, Yo^r peti^c desireth order for his bill & acc^{ot} & as in Dutie bound shall Pray

on the Back side of th^e bill thus Jn^o Buns bill for 500^{lb} tob: after bill th^e Same day one pare of home made stockings 50;

This bill bindeth me John Bun of th^e County of Sommersett plantor my heires executors & adm^{rs} unto Randall Revell of th^e County afores^d gent his heires execut^{rs} adm^{rs} or assignes in th^e full & Just summe of five hundred pounds of good marchantable tobacco & Caske without ground leaues or seconds to be paid upon demand in testimony whereof I haue hereunto sett my hand & seale this third day of August one thousand Six hundred Sixty scaven John Bun (seale)
