

Liber FF This Indenture made the thirtyeth day of October one Thousand six hundred sixty and five & in th^e seaventeenth yeare of the Reigne of our Souaigine lord Charles th^e second by the grace of God King of England Scotland France & Ireland Defender of th^e faith &c Betweene Humfry Warren of Hattons point in Maryland in the p^{ts} beyond th^e seas m^{cht} on th^e one p^{ty} & W^m Barrett of th^e Citty of London m^{cht} on the other party Wittneseth That th^e s^d Humphry Warren doth by theis presents acknowledge & Confesse that he hath at seūall dayes & tymes before the date hereof received & had of & from th^e said W^m Barrett seūall Goods M^rchandizes serv^{ts} & Comodities at Maryland aforesayd to trade & m^rchandize with, there to & for th^e proper use accompt & benifitt of th^e s^d W^m Barrett as his Factor in that behalfe & th^t upon making up th^e Accompts for the same he the s^d Humphry Warren is & standeth Justly indebted unto th^e said W^m Barrett in the full su^me & quantity of one hundred twenty & five thousand pound weight Neat of Virg^a tobacco amounting to th^e full value And su^me of seaven hundred Eighty & one pounds & five shillings of lawfull Money of England And th^e s^d Humphry Warren doth by theis presents alsoe acknowledge & Confesse th^t (by and wth th^e goods m^rchandizes Serv^{ts} & Comodities afores^d soe by him re^{cd} as afores^d) he the said Humphry Warren hath lately bought & purchased to him & his heires foreū a certeyne planta^on of land with th^e app^{tn}nces hereafter men^oned called Hattons poynt or by whatsoeū other name or names th^e same is Called or knowne scituate in Maryland afores^d, And this Indenture further Wittneseth that th^e s^d Humphry Warren as well for & towards th^e security of payment & satisfac^on of th^e s^d su^me & Quantity of virginia tobacco amounting to th^e vallue & su^me of mony afores^d soe to him due & Owing as afores^d as alsoe in considera^on of th^e su^m of Five shillings of lawfull money of England to him th^e s^d Humphry Warren in hand att or before the ensealing & deliūy of theis p^{nts} by the said W^m Barrett well & truly Satisfied & payed whereof the sayd Humphry warren doth hereby acknowledge the receipt & thereof & of eū p^{te} & parcell thereof doth cleerly acquite & discharge th^e s^d W^m Barrett his heires Executo^{rs} Adm^{rs} & assignes & eūy of them for eū by theis p^{nts} Hath given granted bargayned sold Alyened Enfeoffed confirmed & assured And by theis p^{nts} doth fully cleerly & absolutely give Grant bargaine sell Alien Enfeoffe confirme & assure unto th^e s^d W^m Barrett his heires & assignes for eū All th^t planta^on of land wth the appurten^{nces} called or knowne by th^e name of Hattons or by what other name or names the same is called or knowne Scituate lying & being att or neere Hattons poynt in maryland afores^d, now or late in th^e tenure or Occupa^on of him th^e s^d Humfry Warren his undertennant or tennants assignee or assignes Together with all singuler Messuages howses Edifices buildings Out houses Barnes Stables Yards Gardens Ordchards lands arrable pastrs Meadowes
