ing Know ye th^t th^e s^d Thomas Ellis hath Nominated Constituted & appointed & by these p^rsents doth Nominate Cōstitute & Appoint Thomas Fisher of the s^d city Merch^t & W^m Luffe of the same city Merchant his true & lawfull Attorneys Jointley & Either of them seūly for him & his name & to th^e use of the s^d Thomas Ellis to aske leavy Demaund Recouer & Receive of & from all & Eūy such p^rson & p^rsons whatsoever living & Resideing in any part or parts beyond the seas w^h are or were any wayes Indebted unto the s^d Richard in his life time or unto the s^d Thomas Ellis Administrato^r as afforesd since th^e decease of him the s^d Richard Atkins any sume or sumes of Money due & oweing to the s^d Richard Atkins in his life time by bill bound speciallty accompt or otherwise or for any goods wares or Merchandizes whatsoever whereof hee the s^d Richard was in his life time possessed or Interested Giveing or hereby Graunting unto the s^d Attorneys Joyntly or Either of them seūly for him the s^d Thomas Ellis & in his name & to his use full power & Authority in case of non payment of such Moneys or not Delivery of such goods or Merchandizes soe as Affores^d to sue & Prosecute all & eūy the p^rsons affores^d & to p^rceed to Judgm^t & Execution according to the lawes & Customes of such place & places where such p^rson or p^rsons shall Inhabite & reside & alsoe th^e s^d Thomas Ellis Administrato^r as affores^d doth alsoe give full power & Authority to his s^d Attorneys Joyntley & seūly for him & in his name to give such acquittances releases & discharges in the p^rmisses as shall be requisite & Necessary and alsoe to substitute & appoint one or more attorney or Attorneys under him or them and to doe Execute & p^rforme all & Eūy other act & acts thing & things w^tsoever as fully & Effectually as th^e s^d Thomas Ellis Administrato^r as affores^d may or might doe the same being p^rsonally p^rsent Rati-feying & alloweing all & w^tsoever his s^d Attorneys Joyntly or Either of them seūly shall doe or cause to be done in the p^rmisses by these p^rsents In wittnes whereof the s^d Thomas Ellis hath hereunto putt his hand & seale the Eleventh day of Septemb^r Anno RR C Caro^s Secdd Ang^l & Visesimo primo 1669 Thomas Ellis (sealed)
