Ordered by the Court here to witt the eleventh day of February in the xxxviiith yeare of the Dominion of Caecilius &c Annoꝝ Doñ MDCIxi That the fines be eſtreated to the ſeverall Sheriffs of this Province whereupon afterwards to witt the nineteenth day of the ſame February in the yeare aforesaid it was required and comanded the ſeverall and reſpective Sheriffs that they levy of each and every the perſons here abovenamed the ſeverall and reſpective ſummes upon their Severall and reſpective heads sett as fines forfeitures and amerciaments imposed upon them and each of them reſpectively and what thereof ſhall be by them ſo levyed to give an accompt thereof and pay to M^r Thomas Notley Generall Collector for his Lōpp in this province appointed and thereof they are not to faile &c.

Memorandum That On the ſeventeenth day of December in the xxxviiith yeare of the Dominion of Caecilius &c Annoꝝ Doñ One thousand ſix hundred ſixty nine the Jurors for his Lōpp doe preſent Thomas Hatton and Daniel Clocker of S^t Maries Overſeers for the Highwayes for neglecting to make the Highwayes paſſable, whereupon it was comanded the Sheriff of S^t Maries County that he cauſe to come here to witt the eighth day of February in the yeare aforesaid the ſaid Thomas Hatton and Daniel Clocker to answer the pre-miſſes and afterwards to witt the eleventh day of the ſame February in the yeare aforesaid came the ſaid Thomas Hatton and Daniel Clocker and hearinge the abovesaid preſentment read and proclamation being made none appeareing to proſecute Ordered that the ſaid preſentment be quaſhed.
