That the said Tract of Land called Turkey Quarter otherwise called Clarks otherwise called Clarks Quarter shall and may be sold and Conveyed and the money thence arising applied and disposed of by the Same Person or Persons and in like manner as the Lands directed by the said Will are or were thereby to be Sold and conveyed and the moneys thence arising to be applied and disposed of and as if the said mentioned Tract of Land had been particularly and expressly named and mentioned in the Will aforesaid amongst the Lords of the Said Henry Woodward directed to be sold by the Said Will and the Purchaser or Purchasers of the said Tract of Land shall be Equally secured and benefited by such Sale and Conveyance to be made as aforesaid And the Heirs of the said Henry Woodward and all persons whatever claiming under him or them shall be thereby as effectually bound and barred as if the said Tract of Land had been Expressly mentioned and named as aforesaid—in the Will aforesaid. Saving to the Right Honourable the Lord Proprietary his Heirs and Successors and to all Bodies Politick and Corporate and their successors and all others not mentioned in this Act their Several and respective Rights.

[No. XXIV] Province; and for the Encouragement of Jonas Green, of the
City of Annapolis, Printer.

p. 414 Be it Enacted, by the Right Honourable the Lord Proprietary,
by and with the Advice and Consent of his Lordship's Governor,
and the Upper and Lower Houses of Assembly, and the Authority
of the same, That there shall be allowed to Jonas Green, of the City
of Annapolis, Printer, the several and respective Sums of Current
Money, in the several Counties within this Province, following,
to wit, In Baltimore County, Thirty Pounds: Anne-Arundel County,
Twenty-five Pounds Ten Shillings: Charles County, Twenty-three
Pounds Ten Shillings: Prince-George's County, Twenty-three
Pounds: Frederick County, Twenty Pounds Ten Shillings: Queen-
Anne's County, Twenty Pounds Five Shillings: Saint Mary's
County, Nineteen Pounds Ten Shillings: Dorchester County,
Eighteen Pounds Ten Shillings: Kent County, Eighteen Pounds
