Read the Second time the Bill Entituled An Act for the Advancement of Justice and with the following Amendments will pass 2.<sup>d</sup> Page 5.<sup>th</sup> Line from the Bottom leave out the Words to plead to issue the first Court and so to the End of that page and instead thereof insert the following Words to proceed to tryal the same Court and if Def.<sup>t</sup> shall refuse or neglect to Answer or plead to render Judgment for the Plaintiff with Cost of Suit unless Sufficient Cause be shewn by the Defend.<sup>t</sup> why there should be an Impartance after the Word dispute, in the 2.<sup>d</sup> Line of 3.<sup>d</sup> Page instead of the Words shall not exceed the Sum of Twenty Pounds Sterling Money or five thousand Pounds of Tobacco Insert the following Words Viz.<sup>t</sup> is not of Sufficient Value to run the Same into Chancery, after the Words have in 4th. Line of 4th. Page insert the following Words Viz.<sup>t</sup> in his own Name as Assignee after the Word had in 6th. Line of 4th Page insert the following Words, Viz.<sup>t</sup> the said assignment being first recorded in the same Court wherein the Judgment shall have been rendered or obtained and in 6th Line from the Bottom of the same Page before Proceeding put equitable Course or after the Word mentioned in 5th.
