Ordered that Col.<sup>o</sup> Tilghman M<sup>r</sup> Ringgold, M.<sup>r</sup> J. Tilghman Col<sup>o</sup> Loyd and M<sup>r</sup> Bealle do prepare and bring in a Bill accordingly.

On Motion Ordered that the Accounts for the Charges and Expences of the Militia which were inserted on the Journal be taken from it and inserted in the Bill Ordered to be brought in for that purpose.

On Motion of M<sup>r</sup> James Tilghman that An Address be prepared to his Excellency requesting him to lay before this House any Instruction he may have from his Majesty or his Ministers or from the Lord proprietary by which he is restrained from giving his Assent to any Regulation of Money in the Inspection Law

Ordered that M<sup>r</sup> J. Tilghman Col.<sup>o</sup> Tilghman M<sup>r</sup> Ringgold M<sup>r</sup> Hammond M<sup>r</sup> J. Hall & M<sup>r</sup> Murdock do prepare and bring in an address accordingly.
