

Hereupon th^e Plaintife declared against th^e Defend^t in manner Liber C
and forme as followeth

To th^e Wor^{pl}e th^e Commision^{rs} of Charles Countie

Whereupon th^e said John Complaineth against th^e said Bennet for
th^t th^t is to say That Whereas th^e said Bennet became indebted unto
th^e said John in th^e Summe of 2777th of tobaccoe, & being soe
indebted obliged himselfe by Bill bearing date th^e 26th of Februarie
1666 and Signed Sealed and delivered as his act and deed to th^e
said John for th^e true payment of th^e same to have been made
according to th^e said Bill at or before th^e 10th Day of November
last past on th^e said Bennets owne Plantacon yet Notwithstanding
th^e said Bennet litle regarding his said obligacon but plotting and
fraudentlie intending him th^e said John of th^e said 2777th of
tobaccoe to deceave and defraud th^e same to him th^e said John
at th^e time and place according to his said obligacon hath not
paid and delivered or in anie manner for th^e same satisfied but
th^e same to him hitherto to pay & deliver hath altogether refused
and as yet refuseth to th^e Dammage of him th^e said John Where-
upon he brings his suite.

Hereupon th^e Defend^t brought th^e Sherrife into Court to Con-
fesse th^t he had received of Bennet Marchagay th^e Defend^t th^e
summe of 1489th of tobaccoe for th^e use of th^e Plaintife in part
of payment of th^e said Bill menconed in th^e Declaracon and for
th^e Remainder being th^e Summe of 1288th of tobaccoe th^e Defend^t
acknowledged a Judgment for th^e same to th^e Plaintife

Ordered Therefore th^t th^e Defend^t Satisfie and Pay unto th^e
Plaintife th^e said Summe of 1288th of tobaccoe wth Costs of suite
or else Execucon.
